2. kahtatanilis tapalewiti gama gichiwaga ama' taihkuiluh.
3. Gipia ke guhmaga sehsesa ama' taihkuiluh pa sehse tahtanilis. Kua' unu mia' tahtanilis pa sesa taihkuiluh, yi weh musa muinkuiluwa pa sesa ama'.
4. Dah muhmaga ama' waseyu' taga' yeh yawi pa ituga, gipia ke giwiga se ama' taihkuiluh pa ituga wa umextiga iyihkuiluh seyu' taga' u siwa'. Dah se kahtanechigulu u kahtama'xtalis, ama' weh muchiwa wa ipresentanteh legal, se yeh tagatagetzah u seyu' yeh gena gipia ama' ga yeh weh gihkuiluwa.

4. Aya' weh mutahtani kumati ama' taihkuiluh yeh gihtuwa yi formatoh.
